

Harmful Speech in Sri Lanka



Hate speech refers to any kind of communication in speech, writing or behaviour, that attacks or uses pejorative or discriminatory language with reference to a person or a group on the basis of who they are, in other words, based on their religion, ethnicity, nationality, race, colour, descent, gender or other identity factor.

HARMFUL SPEECH TRENDS

According to the methodology employed by the United Nations in Sri Lanka, harmful speech includes hate speech, mis/disinformation, harassment and incitement to or glorification of violence.



Breakdown of identified month-on-month harmful speech by Social Media Platform.

Incidences of harmful speech have been on a broad downward trend since August 2023.

Harmful speech increased by 21% month-on-month from 120 posts in August 2024 to 145 posts in September 2024.

This increase was mainly caused by an 8-fold rise in hate speech targeting ethnic and/or religious minorities that followed the declaration of results of the presidential election on 21 September.

Post-election harmful content included derogatory references to minority communities in the Northern and Eastern provinces, as well as the estate sector, in response to their voting preferences.

While marking a 15% month-on-month decrease, disinformation remained elevated in September.²

United Nations Global Principles for Information Integrity

The United Nations Global Principles for Information Integrity present a vision of a future in which power imbalances are redressed so that a small group of actors, including technology companies based in a handful of countries, no longer monopolize control over global information flows.

The five principles envision an information ecosystem that delivers choice, freedom, privacy and safety for all, in which people everywhere can express themselves freely and make informed and independent decisions.

A Comprehensive Methodology for Monitoring Social Media

UNOSAPG, with support from the United Kingdom, recently launched a <u>Comprehensive Methodology for Monitoring Social Media</u>. Building upon a long-term engagement with tech and social media companies, the methodology sets out a systematic approach to monitoring hate speech based on the <u>UN Strategy and Plan of Action on Hate Speech</u> and in full respect of international human rights law and standards.
